



Golden Ticket Online Arcade Referral & Affiliate Program Policy

Last Updated: March 2026

Golden Ticket Online Arcade (“GTOA,” “we,” “us,” or “our”) may offer promotional referral programs and affiliate partnerships that allow players and marketing partners to introduce new users to the Platform.

This Referral & Affiliate Program Policy explains how referral incentives and affiliate relationships operate on the Platform. Participation in any referral or affiliate promotion is subject to the Terms & Conditions, Sweepstakes Rules, and all applicable policies of Golden Ticket Online Arcade.

Participation in the referral program is optional and promotional in nature.

1. Referral Program Overview

Golden Ticket Online Arcade may provide players with the ability to invite eligible individuals to join the Platform through a referral link, referral code, or similar invitation mechanism available through their account.

When an eligible new player registers using the referring player’s referral link or code and completes the required steps described below, the referring player may receive a promotional bonus.

Referral programs are offered as community engagement and promotional initiatives and may change from time to time.

2. When a Referral is Considered Successful

A referral is considered successful only when all of the following conditions are satisfied:

- The referred user registers using the referring player’s referral link, referral code, or affiliate tracking link
- The referred user creates a valid Customer Account in accordance with the Platform’s Terms & Conditions
- The referred user completes any required identity or account verification steps
- Any applicable promotional conditions associated with the referral promotion are satisfied

Only referrals that meet these conditions will qualify for promotional referral rewards.

3. Referral Rewards



Players may receive promotional incentives when a qualifying referral is completed.

Referral rewards may include:

- Promotional Sweepstakes Coins (SC)
- Promotional Gold Coins (GC)
- Other promotional in-platform credits offered as part of a specific promotion

The type and amount of referral rewards may vary depending on the promotion available at the time.

Referral rewards are promotional incentives only and do not represent payment or compensation for recruiting users.

4. Promotional Nature of Referral Bonuses

Referral bonuses are offered solely as part of Golden Ticket Online Arcade's marketing and community engagement efforts.

Referral bonuses:

- are promotional in nature
- may vary depending on the promotion available at the time
- may be modified, limited, or discontinued at any time

Participation in the referral program does not create an employment, partnership, or compensation relationship between the referring player and Golden Ticket Online Arcade.

5. Referral Program Restrictions

Golden Ticket Online Arcade reserves the right to review referral activity and may withhold, delay, revoke, or deny referral rewards where any of the following is detected:

- duplicate accounts
- Self- referrals
- fraudulent activity
- automated account creation
- abuse of the referral program
- violations of the Terms & Conditions or other platform policies



Golden Ticket Online Arcade may also limit the number of successful referrals that may qualify for rewards per Customer Account.

6. Affiliate Program

Golden Ticket Online Arcade may also work with approved marketing partners or affiliates who promote the Platform using referral links, promotional codes, or similar tracking mechanisms.

Affiliate partners may operate under separate marketing or affiliate agreements that govern their promotional activities and compensation structure.

Affiliate relationships may include:

- promotional partnerships
- content creator collaborations
- digital marketing campaigns
- advertising and community outreach initiatives

Affiliate partners must comply with all applicable laws, advertising standards, and Golden Ticket Online Arcade policies when promoting the Platform.

7. Compliance and Monitoring

Golden Ticket Online Arcade reserves the right to monitor referral and affiliate activity to ensure compliance with platform policies and applicable laws.

Where suspicious activity or policy violations are identified, Golden Ticket Online Arcade may:

- withhold referral rewards
- suspend referral eligibility
- terminate referral participation
- close accounts involved in abuse or fraud

All determinations regarding referral eligibility and rewards are final and binding.

8. Relationship to Platform Terms

Participation in any referral or affiliate program is subject to:



- the Golden Ticket Online Arcade Terms & Conditions
- the Sweepstakes Rules
- all other applicable platform policies

If any conflict exists between this policy and the Terms & Conditions, the Terms & Conditions will control.

9. Modifications to the Referral Program

Golden Ticket Online Arcade may modify, suspend, or discontinue the referral or affiliate program at any time for business, legal, or compliance reasons.

Any updates to this policy will be posted on the Platform.
